Due to an accidental slip, the initial paragraph of section 6 of the Water risk treatment plan (Tabled Documents 508 and 508a) was not updated as we had intended. This paragraph should have been updated as follows:

6. Acceptance criteria Acceptance criteria are the measures which, if attained, are the basis for concluding that the control measures described in this plan have been effective in achieving the plan objectives. The acceptance criterion for this risk treatment plan is that the diversion and return of diverted water to the environment does not detract from beneficial uses on uncertained and the Environmental Reference Standard (ERS). Beneficial uses dictated by water quality will be considered to be adequately protected if: Image: Interpret the environmental values will be considered to be adequately protected if: Image: Interpret to exceed the relevant criteria specified in the ERS and summarised in Table 6-2;

receiving waters to exceed the relevant criteria <u>specified in the EKS and</u> summarised in Table 6-2; and <u>and</u> <u>• it is not reasonably practicable to further reduce any risk of harm to human health or the</u> <u>environment associated with the environmental value.</u>

These updates are in line with other changes made to the risk treatment plans (i.e. to reflect the requirements of the new Environment Protection Act, including the reference to the ERS and the requirements of the general environmental duty). We have updated both the 'tracked change' and 'clean' versions of the Water risk treatment plan to include this update – please cee copies attached. Would it be possible to replace the documents currently included as Tabled Documents 508 and 508a with the attached versions?
