1. INTRODUCTION

- I previously prepared an expert report on the planning merits of the Fingerboards Mineral Sands Project (the 'Project') including Amendment C156egip (the 'Amendment') to the East Gippsland Planning Scheme (the 'Planning Scheme').
- 2. I have subsequently been requested to provide an addendum statement dealing specifically with the centrifuge aspect of the proposal.
- 3. As with my original evidence statement, I provide a town planning opinion only.

2. PLANNING EVIDENCE

- 4. A centrifuge is a specialist piece of equipment, which, as I understand it, in simple terms separates fluids of different densities. If no centrifuge is required, then less water will be used and there will be no need for tailings storage.
- From a town planning perspective, the presence or otherwise of one or more centrifuges as part of the Project does not change my broader town planning assessment of the Project and the Amendment.
- I say this on the basis that any centrifuge forms part of the Project, is located on the Project Land (refer Appendix A in my original statement) and does not impact the Amendment.
- 7. While a centrifuge may impact the broader consideration of the EES, it does not alter my town planning evidence or affect any of its conclusions. I would expect that any noise impacts associated with the centrifuge to be appropriately managed. The lack of any tailings storage would presumably have some positive visual impacts. Although I am not qualified to comment on landscape impacts, I do not think that this issue would be determinative (one way or the other).



8. In summary, a centrifuge is a specialist matter for which I am not qualified to comment on, and I have no town planning comments to make in relation to the centrifuge aspect of the proposal.

3. CONCLUSION

- 9. My view in relation to this matter is unchanged from the opinion I expressed in my original evidence statement.
- I have made all inquiries that I believe are desirable and appropriate and that no matters of significance which I regard as relevant have to my knowledge been withheld from the IAC.
